Open Session

Call to Order – Chair Simon Whitelocke called to order a duly noticed open Annual Meeting of the Members on December 8, 2022, at 9:03 am (ET). A quorum of the members of ReliabilityFirst Corporation (RF) was present. A list of these members is set forth in Attachment A. A list of others present during the Annual Meeting of the Members is set forth in Attachment B.

Appoint Secretary to Record Minutes – Chair Whitelocke designated Niki Schaefer, RF's Vice President and General Counsel, as the secretary to record the meeting minutes.

Antitrust Statement – Ms. Schaefer advised all present that this meeting is subject to, and all attendees must adhere to, RF's Antitrust Compliance Guidelines.

Chair's Remarks and Welcome – Chair Whitelocke welcomed all attendees to the meeting and introduced the keynote speaker, David Ortiz, Director of FERC's Office of Electric Reliability (OER).

Keynote Speaker – Mr. Ortiz shared FERC's focus areas and provided an overview of what the OER does, which includes implementing Section 215 of the Federal Power Act by advising the Commission on whether to approve Reliability Standards, overseeing compliance, providing engineering support to rate filings and offices that manage Commission work, monitoring the status of the BPS, and working with NERC's situational awareness team to review major events.

Mr. Ortiz also discussed inverter-based resources, interconnection reforms, and current priorities for the OER, which include: maintaining a reliable and secure electric system with Reliability Standards updated for the system we are moving toward; FERC and NERC working together whenever they can to provide effective reliability oversight; and ensuring cybersecurity coordination across the industry. He spoke about proposed changes to registration for inverter based resources, and there was a discussion around the potential types and thresholds for registration of these resources. There was also discussion on the importance of coordination with other industries (such as natural gas), and plans for future collaboration between FERC, NERC, and the Regions such as situational analysis teams.

President's Report – Tim Gallagher, RF's President and CEO, began by thanking Mr. Ortiz for being a steady hand and driving force leading the OER. He welcomed Ken DeFontes, Chair of NERC's Board of Directors and a founding member of RF, and thanked Jim Robb, NERC's President and CEO, for being present. He also welcomed Lesley Evancho and Scott Hipkins to the Board, noting they will fit in seamlessly and bring a wealth of knowledge and expertise. He congratulated and welcomed back Jennifer Sterling, Ben Felton, and Joe Trentacosta, following their reelection as members of the Board.

Mr. Gallagher shared that RF was selected for a third time as a top workplace in Ohio, noting he was initially concerned that the pandemic would impact engagement, but the results were higher than before. He also noted RF's recent work serving as a technical resource to state legislatures and public utility commissions. He highlighted Diane Holder joining the RF executive team as VP of Entity Engagement and Corporate Services, and the recent promotion of Jeff Craigo to Senior VP of Reliability and Risk. He shared that he is optimistic with the direction the organization is heading in terms of diversity and noted the number of diverse hires made in 2022. Mr. Gallagher shared the goal of wanting to emerge from the pandemic better than before, and said that the one day a week in-office policy is working well, is appreciated by staff, and is helping to recruit more diverse talent.

Mr. Gallagher highlighted recent work by Marcus Noel, RF's Chief Security Officer (CSO), and his team to combat ransomware and conduct tabletop exercises that have been shared with other Regions. He shared that NERC and all the Regions have developed common data classifications, and that RF has seen an improved misoperations rate. He discussed a recent training with the Board Officers and Independent Directors at Eaton Corporation where they spent a day visiting a mockup substation, wind farm, and solar center. Mr. Gallagher also commented on RF's winter readiness visits to generation facilities, and thanked Mr. Noel and Ms. Tortora for their work associated with RF co-hosting GridSecCon.

Mr. Gallagher shared that next year marks the twentieth anniversary of the 2003 blackout, the largest blackout in the history of the world. He highlighted progress made and shared the importance of collaboration as the industry faces the challenges of decentralization, digitization, and decarbonization. He noted the effort necessary to continue addressing well known risks so that we can be proactive and resilient. In closing, Mr. Gallagher posed two challenges to the industry: first, noting that he is a believer in a self-regulating model where the industry sets their own standards, to challenge industry to stay as active as they can in the NERC Standards process; and second, to challenge industry in their compliance efforts to seek excellence and find and address previously unknown risks.

Election of an At-Large Director and Independent Director – Joanna Burkey, Chair of the Nominating and Governance Committee, presided over the election of the At-Large and Independent Directors. They will serve 3-year terms through December 2025. Ms. Schaefer announced that Mr. Joe Trentacosta was elected as At-Large Director and Ms. Lesley Evancho was elected as Independent Director.

Overview of Financial Position– Carol Baskey, RF's Treasurer and Manager of Finance and Accounting, provided an overview of the company's 2022 financial information. She discussed RF's 2022 budget year end projections, as well as the overall ERO Enterprise year end projections. She noted that RF is projected to end \$707K under budget, primarily due to unfilled positions in the first half of the year, and lower meeting and travel expenses due to the pandemic. Ms. Baskey then discussed the 2023 Business Plan and Budget that was approved by FERC in November. She also noted that RF had a clean financial audit, and highlighted recent continuous improvements such as enhanced budget reporting and expense reporting processes.

Mr. Gallagher thanked Chair Whitelocke for his last meeting serving as Board Chair. He shared that he appreciated his service and his help throughout the pandemic. He also noted his thoughtful stewardship and assistance in finding outstanding independent directors. Chair Whitelocke said it was an honor and a privilege to serve as Chair of the RF Board.

Comments from Members – Chair Whitelocke provided an opportunity for Members to provide comments.

Future Meeting – Chair Whitelocke announced the next Annual Meeting of Members was tentatively scheduled for December 7, 2023, in either Cleveland or Washington DC.

Adjourn – Upon a motion duly made and seconded, Chair Whitelocke adjourned the Annual Meeting of Members at 10:04 am (ET).
