- 1. Welcome, Attendance and Introductions
 - a. The SC was welcomed, and attendance was taken.
- 2. Review Anti-Trust Statement
 - a. Tony reviewed the Anti-Trust Statement
- 3. Approve January 30, 2024 Draft Minutes
 - a. Motion: Approve January 30, 2024 Draft Minutes

 - e. Vote: The January 30, 2024 draft minutes were approved by the SC
- 4. Mark Kuras (PJM) to discuss the NERC <u>Project 2022-03</u> Energy Assurance with Energy-Constrained Resource Drafting Effort
 - a. Mark Kuras walked through a presentation on the Project 2022-03 Energy Assurance with Energy-Constrained Resource Drafting Effort primarily focusing on the first draft standard which is BAL-007-1 (operating time horizon). This draft standard is currently out for industry comment until March 11, 2024 (with most likely a forthcoming Ballot). Mark used a presentation that will be shared with the group. Mark answered a number of questions from SC Members and Observers throughout the presentation.
 - b. In regard to the planning time horizon version of this Project 2022-03 effort, Mark noted there is an initial draft being formed and TPL-001 and the RF BAL-502-RF-03 Standards are being looked at as starting points. Mark noted this effort is being worked on in parallel with the operating time horizon effort. Mark gave an estimate that the Planning version is approximately a month away from its first posting for comments and potentially will be completed by the end of 2024.
- 5. Bobbi Welch (MISO) to discuss/answer questions on the MISO submitted BAL-502-RF-03 submitted Five-year Review comments.
